| <b>1.</b>   | <b>Membership</b>  |
| <b>1.1</b>  | The Committee shall comprise of a Committee Chair and at least 2 other members, and where possible, include one member of the Remuneration Committee. All of whom will be independent non-Executive Directors. The Company Chair shall not be a member of the Committee.   |
| <b>1.2</b>  | Appointments to the Committee shall be made by the Board on the recommendation of the Nomination Committee, in consultation with the Committee Chair.  |
| <b>1.3</b>  | Any appointments made shall ensure that at least one member of the Committee has recent and relevant financial experience, and with competence in accounting and/or auditing. The Committee as a whole shall have competence relevant to the sector in which the Company operates.   |
| <b>1.4</b>  | Only members of the Committee have the right to attend committee meetings. However, the Committee may at its discretion invite any other persons to attend all or part of its meeting as appropriate.  |
| <b>1.5</b>  | The Chair of the Company, Finance Director, Director of Group Risk and Audit and external audit lead partner will be invited regularly to attend meetings.   |
| <b>1.6</b>  | The Committee has the right to meet the Company’s internal or external auditors without the presence of any executives.  |
| <b>1.7</b>  | The Company’s external auditors or internal auditors may request a meeting if they consider one is necessary.  |
| <b>1.8</b>  | Appointments to the Committee shall be for a period of up to three years, which may be extended by no more than two additional three-year periods, provided the director remains independent.  |
| <b>1.9</b>  | In the absence of the Committee Chair, the remaining members present shall elect one of their number to chair the meeting.   |
| <b>1.10</b>   | The quorum necessary for the transaction of business shall be any two members. A duly  |

|           | <b>5.1</b>                      | The Secretary shall minute the proceedings and resolutions of all meetings of the Committee, including recording the names of those present and in attendance.   |
|           | <b>5.2</b>                      | The Secretary shall ascertain, at the beginning of each meeting, the existence of any conflicts of interest and Minute them accordingly.   |
|           | <b>5.3</b>                      | Minutes of Committee meetings shall be distributed promptly to all members of the Committee and, once agreed, to all members of the Board.   |

|           |                  | <b>9.2.1</b>  | to seek any information it requires from any officer or employee of the company or its subsidiaries in order to perform its duties;  |
|           |                  | <b>9.2.2</b>  | to obtain, at the Company's expense, outside legal or other professional advice on any matters within its terms of reference. The Committee will inform the Finance Director and the Board of any such action; and |
|           |                  | <b>9.2.3</b>  | to call any member of staff to be questioned at a meeting of the Committee as and when required.   |
